

How Is UKUPC Supporting Supply Chain Management?

THE WAR IN UKRAINE

While we continue to see the impacts of Brexit and Covid on supply markets, we have also been assessing the impact of the ongoing Russian invasion of Ukraine. We are working closely with our supply base to assess continued disruption. UKUPC Partners have:

- Confirmed that no framework suppliers are registered in Russia or Ukraine.
- Recognised that there may be links further down the supply chain, and we continue to work with our suppliers to assess potential impact. The Market Insight document captures all our category knowledge and will be invaluable to anyone in a member organisation who may be affected by these topics. Both the UK and Scottish Governments have published Procurement Policy Notes in relation to handling supply chains impacted by the war in Ukraine.

A RECOVERING TRAVEL SECTOR

We have worked closely with our suppliers to put action plans in place to improve service from suppliers on the national **Travel Management Services Framework**. Travel Management Companies (TMCs) are all experiencing largely the same issues:

- Increased demand for bookings.
- Changes in travel policies due to COVID-19.
- Changes in restrictions and regulations globally.
- Requirements for more offline assistance and support for supply chains (hotels, airlines, car hire etc).
- Recruitment and training of service personnel to meet increased demand.

Russia's invasion of Ukraine has also had a major effect with TMCs working to extract travellers from the area. There have been increased bookings from humanitarian organisations to put aid workers on the ground. In addition, the closure of airspace over Russia has resulted in flights being diverted and many journeys being delayed and or cancelled.

As always, communication and collaboration are key. While we meet monthly, communication between your Joint Contracting Group occurs daily. New information gained through discussions with our members always helps us develop advice and inform guidance to support all.

FINANCIAL SUSTAINABILITY: YOUR SAVINGS AND SUPPORT THROUGH UKUPC

Through collaborative working, UKUPC partners avoid needless duplication across the UK, build resilience and deliver measurable value to members. Our latest Impact Statement shows how our collaboration has delivered tangible value to members in the last year.

Here are some highlights:

- ▶ Members spent **£1.3BN** through consortia frameworks and achieved **£76M** in cashable savings and **£104M** in non-cashable/process savings.
- ▶ Members had access to **over 100 agreements** covering a wide range of strategic spend areas for your institution.
- ▶ Members accessed **risk assessments and best practice guides, along with guidance and support** to address significant challenges such as thriving in a new normal, managing major disruptions to the supply chain and supporting sustainability.
- ▶ Members had access to **180 SMEs** through UKUPC frameworks – SMEs make up just over **60%** of our awarded suppliers across all frameworks.

ADOPTING AND EMBEDDING RESPONSIBLE PROCUREMENT: RESOURCES FOR YOU

Your UKUPC Responsible Procurement Network has a range of resources to help members improve their sustainable procurement practices, including:

- **Carbon reduction plan for SMEs** supplying the HE Sector. The guidance has been shared with all awarded frameworks suppliers and covers areas such the benefits of having a carbon reduction plan; ways to reduce your carbon footprint; and steps to develop a plan. The guidance aims to help minimise the impact of the sector's activities on the environment.
- **Sustain Supply Chain Code of Conduct.** We are committed to carrying out procurement activities in an environmentally, socially, ethically and economically responsible manner and to entering into agreements and contracts with suppliers that share and adhere to our vision. The standards in this Code are derived from established global

conventions and standards, including the United Nations Sustainable Development Goals (UN SDGs), ETI base Code and International Labour Organisation Conventions. To demonstrate this commitment, current and potential suppliers are asked to commit to responsible/sustainable procurement within their organisations and to acknowledge their compliance with the principles of the Sustain Supply Chain Code of Conduct. **This code has also been adopted by the HEPA Responsible Procurement Group** as the recommended standard for UK HE institutions.
